The Future of Labor and Employment law. This is the subject of a three-year research program undertaken by a group of researchers at the University of Lorraine with the financial support of the National Research Fund (ANR) and under the scientific direction of Professor Frederic Gea.

During the previous stages of the research, on the Future of Labor and Employment Law, our research considered the evolutions of the French legal system during the past two decades and tried to analyze the contours of the legal model(s) propelling the evolution. This ultimate stage will seek to enlarge the scope and depth of our research topic by analyzing similar (or dissimilar) developments at global level (worldwide). In order to do so, we wish to focus on "country experience" so as to test our principle hypothesis that there are one or more emerging legal models in action today. As a result, our research will be fully orientated towards comparison with a view to identify as much as possible these models.

The evolutions of domestic labor and employment law are mainly explained, at least within the official discourse, by references to globalization, digitalization, and global crisis (such as financial, health, social or environmental). These common explanations, challenge well established legal categories and seem to command the transformation of work itself. However, this discussion cannot remain circumscribed within the frontiers of a specific territory such as a country or a nation. The discussion naturally transcends territorial anchoring in the most radical way. This is why theoretical analysis on the future of labor and employment law needs to be elevated beyond national borders.
